The North was shocked by such events as Grant's attack at Cold Harbor, during which seven thousand Union soldiers were killed in twenty minutes, and the Battle of the Crater, where three thousand Union men died in a bungled attempt to blow up Confederate trenches. The year became so bleak that on August 23, Lincoln wrote in a memorandum, “This morning, as for several days past, it seems exceedingly probable that this Administration will not be reelected.” But, with the increasing success of his generals, and a majority of the American public ready to place its faith in him, Lincoln and the nation ended 1864 with the close

of the war in sight and slavery on the verge of extinction. 1864 presents the man who not only saved the nation, but also, despite the turmoil of the war and political infighting, set the stage for westward expansion through the Homestead Act, the railroads, and the Act to Encourage Immigration. Their differing strategies for accomplishing that goal, however, created constant conflict. In *Lincoln and McClellan at War*, Chester G. Hearn explores this troubled relationship, revealing its complexity and showing clearly why the two men -- both inexperienced with war -- eventually parted ways. A staunch Democrat who never lost his acrimony toward Republicans -- including the president -- McClellan first observed Lincoln as an attorney representing the Illinois Central Railroad and immediately disliked him. This underlying bias followed thirty-five-year-old McClellan into his role as general-in-chief of the Union army. Lincoln, a man without military training, promoted McClellan on the advice of cabinet members and counted on "Little Mac" to whip the army into shape and end the war quickly. McClellan comported himself with great confidence and won Lincoln's faith by brilliantly organizing the Army of the Potomac. Later, however, he lost Lincoln's trust by refusing to send what he called "the best army on the planet" into battle. The more frustrated Lincoln grew with McClellan's inaction, the more Lincoln studied authoritative works on military strategy and offered strategic combat advice to the general. McClellan resented the president's suggestions and habitually deflected them. Ultimately, Lincoln removed McClellan for what the president termed "the slows." According to Hearn, McClellan's intransigence stemmed largely from his reluctance to fight offensively. Thoroughly schooled in European defensive tactics, McClellan preferred that approach to fighting the war. His commander-in-chief, on the other hand, had a preference for using offensive tactics. This compelling study of two important and diverse figures reveals how personality and politics prolonged the Civil War.

In this close study of apophasis in Greek, Christian, and Islamic texts, Michael Sells offers a sustained, critical account of how apophatic language works, the conventions, logic, and paradoxes it employs, and the dilemmas encountered in any attempt to analyze it. This book includes readings of the most rigorously apophatic texts of Plotinus, John the Scot Eriugena, Ibn Arabi, Marguerite Porete, and Meister Eckhart, with comparative reference to important apophatic writers in the Jewish tradition, such as Abraham Abulafia and Moses de Leon. Sells reveals essential common features in the writings of these authors, despite their wide-ranging differences in era, tradition, and theology. By showing how apophasis works as a mode of discourse rather than as a negative theology, this work opens a rich heritage to reevaluation. Sells demonstrates that the more radical claims of apophatic writers—claims that critics have often dismissed as hyperbolic or condemned as pantheistic or nihilistic—are vital to an adequate account of the mystical languages of unsaying. This work also has important implications for the relationship of classical apophasis to contemporary languages of the unsayable. Sells challenges many widely circulated characterizations of apophasis among deconstructionists as well as a number of common notions about medieval thought and gender relations in medieval mysticism.

Diana's Tree

Diana's Tree is an important book - written in Paris, where she lived for four years - and the first really mature work (1962) by Alejandra Pizarnik (1936-1972), increasingly recognised as one of the major poetic voices of the second half of the 20th century in Latin America. Mujer Sin Edén

Carmen Conde was born in 1907 in Cartagena (Murcia) where, with the exception of seven years in Melilla, she lived until 1936. At the end of the Spanish Civil War she moved to Madrid. For many years she was a professor of Spanish Poetry and Contemporary Spanish Novel at the Institute of European Studies (an affiliate of the University of Chicago) in Madrid. Also a professor of the University of Valencia. She has been awarded the following literary prizes: Elisenda Moncada, Internacional de Poesía; Premio Nacional de Poesía Española and the Premio de Novela Ateneo de Sevilla (1980). In 1978 was elected chair of the Royal Academy of the Spanish Language, the first woman ever inducted as a member. She gave her inaugural speech to the Academy on January 29, 1979. She died in Madrid in 1996. This book is a bilingual collection of poems of Carmen Conde in Spanish and translated to English. Editions and translation by Alexis Levitin and José R. De Armas with preface by Concha Zardoya and the Nobel Prize Winner, Vicente Aleixandre.

Lugubrious Nights

Feminism and History

The question of difference - between women and men and among women - is at the heart of feminist theory and the history of feminism. Feminists have long debated the meanings of sexual difference: is it an underlying truth of nature or the result of changing social belief? Are women the same as or different from men? *Feminism and History* argues that sexual difference, indeed that all forms of social differentiation, cannot be understood apart from history. It brings together the best critical articles available to analyze the ways in which differences among women and men have been produced. The articles range across many countries and time periods (from the Middle Ages to the present) and they include analyses of western and non-western experiences. Daughter of the Sea

With Eyes at the Back of Our Heads

This book makes available to students and scholars of Spanish Golden Age Drama a carefully prepared semi-critical edition and verse translation of Tirso de Molina's Herod play, a little known masterpiece fusing the two Herods - the historical protagonist of Jewish and Roman history whose life is narrated by Flavius Josephus in "Antiquities of the Jews" and the tyrant-ogre depicted in Biblical and liturgical sources - into a tragic protagonist of archetypal dimensions, a vegetation daimon or year-spirit whose life history prepares the way for the more sublime year-spirit whose nativity and epiphany coincide with Herod's ritual implosion at the end of the play. Professor Fornoff's introduction and notes show us how to read through the plot to the sacramental action which it signifies.

La Vida Y Muerte de Herodes

Is there such a thing as a female literary imagination – a special brand of insight and intuition that characterises women's writing? Is there something about a novel, whether by Jane Austen, Charlotte Brontë or Doris Lessing, that tells us that it could only have been written by a woman? Do the subject matter, form and style that women choose throw light on the way they think and feel? In this brilliant and highly readable book, originally published in 1976, Patricia Spacks analyses the female view of the world. Juxtaposing – sometimes in startlingly original combination some eighty books written between the seventeenth century and the present day she uses both literary and psychological analysis to explore patterns that recur again and again in the stories women tell – whether about their own lives or the lives of their fictional characters. She dissects female experience in the twentieth century as viewed by an array of writers ranging from Kate Millet to Virginia Woolf; examines the interplay of social passivity and psychic power that dominates characters such as Maggie Tulliver and Jane Eyre, the altruism that impels Jane Austen's and Mrs Gaskell's heroines, the 'acceptance' of Virginia Woolf's Mrs Ramsey, the personal and social conflicts that beset so many of the adolescent girls that figure in both nineteenth-century and contemporary literature; reveals the complex motives that can be bound up in a women's deliberate choice of the artist's role, as appears in the writings of Isadora Duncan's and Dora Carrington, Marie Bashkirtseff and Mary McCartney – and the surprising forms 'freedom' can take, as for Beatrice Webb in the East End of London or Isak Dinerson in the wilds of Africa... The voices echo and re-echo across the years in fascinating counter-point. Their range is enormous – rebels and reformers, actresses and painters, Society ladies and unknown girls in small towns, novels, poems, memoirs, diaries and letters, both English and American, and alongside classics such as *Wuthering Heights* and well-known modern works such as *The Bell Jar*, Patricia Spacks introduces an intriguing selection of relatively unknown writers, such as Napoleon's psychoanalyst great-niece Marie Bonaparte, the Victorian arch-fantast Mary MacLane and the autobiography of a seventeenth-century Duchess. *The Female Imagination* is much more than a study of women's writing. It is an inquiry into the nature of female thought, self-expression and experience. As such it should appeal to every educated woman – and to many men too.

The Female Imagination

Students of American history know of the law's critical role in systematizing a racial hierarchy in the United States. Showing that this history is best appreciated in a comparative perspective, *The Long, Lingering Shadow* looks at the parallel legal histories of race relations in the United States, Brazil, and Spanish America. Robert J. Cottrol takes the reader on a journey from the origins of New World slavery in colonial Latin America to current debates and litigation over affirmative action in Brazil and the United States, as well as contemporary struggles against racial discrimination and Afro-Latin invisibility in the Spanish-speaking nations of the hemisphere. Ranging across such topics as slavery, emancipation, scientific racism, immigration policies, racial classifications, and legal processes, Cottrol unravels a complex odyssey. By the eve of the Civil War, the U.S. slave system was rooted in a legal and cultural foundation of racial exclusion unmatched in the Western Hemisphere. That system's legacy was later echoed in Jim Crow, the practice of legally mandated segregation. Jim Crow in turn caused leading Latin Americans to regard their nations as models of racial equality because their laws did not mandate racial discrimination— a belief that masked very real patterns of racism throughout the Americas. And yet, Cottrol says, if the United States has had a history of more-rigid racial exclusion, since the Second World War it has also had a more thorough civil rights revolution, with significant legal victories over racial discrimination. Cottrol explores this remarkable transformation and shows how it is now inspiring civil rights activists throughout the Americas.

Contemporary Spanish Poetry

Roger Chartier examines how authors transformed the material realities of writing or of publication into an aesthetic resource exploited for poetic, dramatic, or narrative ends.

Inscription and Erasure

This poem was written in 1899. It is in blank verse and this was before the yogic phase of Sri Aurobindo's life. This is a poem of the glories of human love, and the height of human sacrifice. This poem is about Ruru and Pramadvura, a story from The Mahabharatha. This poem predates Sri Aurobindo's magnum opus, *Savitri*. This is a classic example of the command of the English language by Sri Aurobindo and his ability to bring to life a rather drab and not well known story from the epic The Mahabharatha. There is an interesting description of Yamaloka, and I leave it to you, the reader to enjoy it!

La poesía de Blas de Otero

Female sexuality as expressed both in the art of women and in images of women in art is the focus of this collection of thirteen essays -- the second in a three-volume series on women, the arts, and society. The idea that art created by a woman has a particular relationship to the female body is explored by most of these essays.

Love and Death

Georges Bataille presents the case of the most infamous villain of the Middle Ages: Gilles de Rais. Fascinated with the depths of human experience--the meeting points of sexuality, violence, ritual, spirituality, and death--Bataille examines with dispassionate clarity the legendary crimes, trials and confessions of this grotesque and still-horrifying 15th-century child-murderer, sadist, alchemist, necrophile and practitioner of the Black Arts. Gilles de Rais began his remarkable career as lieutenant to the devout martyr and saint Joan of Arc; after her execution, he fled to his estates in the countryside of France, where he began to ritually slaughter hundreds of children. After his arrest and subsequent trials, he was hanged and burned at Nantes, France on October 25, 1440. The latter section of *The Trial of Gilles de Rais* consists of the actual ecclesiastical and secular trial transcripts, annotated by Bataille, and translated from the ecclesiastical Latin by Pierre Klossowski.

The Trial of Gilles de Rais

Benito Pérez Galdós was the foremost Spanish novelist of the nineteenth century. His novels are frequently compared with those of Dickens and Balzac, and considered examples of nineteenth-century realism. In a speech before the Spanish Academy of Language, Galdós himself declared that the novel is 'an image of life'; scholars have often considered that image to be an uncritical reflection, or even a biased misrepresentation of the Spanish society of the time. This book shows, by detailed analysis of Galdós narrative techniques, how his novels display a much more skeptical and ironical attitude toward the ability of language to represent reality, than has previously been recognized. Rather than attempting to judge the accuracy of Galdós' image of life the author analyzes the linguistic means by which the novels recreate life in their own image. With close and discriminating attention to detail the author illustrates Galdós' narrative irony with examples from the serie contemporánea, the most highly acclaimed period of his writing. She analyzes the ironic possibilities under three main headings: depiction of characters, description of places, and the narrative voice. A final chapter describes the

fusion of these devices in the novella *Torquemada en la hoguera*. This clearly argued study, structuralist in approach and sensitive to nuances of style and language, will appeal to students of modern critical theory and comparative literature as well as to Hispanists.

Salomé decapitada

Trying to be Ernest Hemingway is never easy. After reading *A Moveable Feast*, aspiring novelist Enrique Vila-Matas moves to Paris to be closer to his literary idol, Ernest Hemingway. Surrounded by the writers, artists and eccentrics of '70s Parisian café culture, he dresses in black, buys two pairs of reading glasses, and smokes a pipe like Sartre. Now, in later life, he reflects on his youth while giving a three-day lecture on irony. And he's still convinced he looks like Hemingway. *Never Any End to Paris* is a hilarious, playful novel about literature and the art of writing, and how life never quite goes to plan.

The black doll

This overview of Cuban history and politics has been updated and revised to include a new afterword on the current political situation and an expanded guide to selected reference literature.

Galdós and the Irony of Language

When the paralyzed cripple Domingo Vidal is rescued unsinged from a burning house, the people of Chima believe they have witnessed a miracle. Domingo becomes their patron "saint," and tales of his miracles multiply. Domingo makes the rains come, cures the blind and lame, and swells barren wombs with new life. But is Domingo really a saint, or is he a pagan idol? Padre Berrocal calls the people heretics, but they are afraid not to worship Domingo. To what excesses will superstition and ignorance drive the frightened people of Chima? This novel, published in 1963 as *En Chimá nace un santo*, makes important connections between the frustrations of poverty and the excesses of religious fanaticism. Zapata Olivella indicts the dogmatic attitudes of religious and civil institutions as a major cause of the creation of local cults like the one that grows up around "Saint" Domingo. In Zapata Olivella's compelling narrative, the struggle over Domingo points up both the inflexibility of established institutions and the potential power for change that lies within the hands of a determined populace.

Their approach thus parallels that of many artists in other mediums who view their art in primarily conceptual terms. This publication, issued in conjunction with a major exhibition at The Museum of Modern Art, is the first to deal comprehensively with these challenging developments. Over 150 objects of Italian design of the past ten years have been selected for the show and are all reproduced in color and black-and-white, as are the dozen environments by well-known Italian designers specially commissioned for the occasion, and the two awarded prizes in a concurrent competition for young designers under thirty-five sponsored by the Museum. Each environment is accompanied by a statement in which the individual or group responsible for the project clarifies his position regarding the present and future role of design. In addition to essays by Emilio Ambasz, Curator of Design at the Museum of Modern Art and director of the exhibition, the book contains contributions by a number of outstanding Italian critics and art historians. Together, these comprise the first historical

Nicomedes Santa Cruz

The documentary, a genre as old as cinema itself, has traditionally aspired to objectivity. Whether making ethnographic, propagandistic, or educational films, documentarians have pointed the camera outward, drawing as little attention to themselves as possible. In recent decades, however, a new kind of documentary has emerged in which the filmmaker has become the subject of the work. Whether chronicling family history, sexual identity, or a personal or social world, this new generation of nonfiction filmmakers has defiantly embraced autobiography. Michael Renov is professor of critical studies at the USC School of Cinema-Television. He is the editor of *Theorizing Documentary* and the coeditor of *Resolutions: Contemporary Video Practices* (Minnesota, 1996) and *Collecting Visible Evidence* (Minnesota, 1999).
