Ajax, the Dutch, the War

When most people think about the Netherlands, images of tulips and peaceful pot smoking residents spring to mind. Bring up soccer, and most will think of Johan Cruyff, the Dutch player thought to rival Pele in preternatural skill, and Ajax, one of the most influential soccer clubs in the world whose academy system for young athletes has been replicated around the globe (and most notably by Barcelona and the 2010 world champions, Spain). But as international bestselling author Simon Kuper writes in *Ajax, The Dutch, The War: Soccer in Europe During the Second World War*, the story of soccer in Holland cannot be understood without investigating what really occurred in this country during WWII. For decades, the Dutch have enjoyed the reputation of having a "good war." The myth is even resonant in Israel where Ajax is celebrated. The fact is, the Jews suffered shocking persecution at the hands of Dutch collaborators. Holland had the second largest Nazi movement in Europe outside Germany, and in no other country except Poland was so high a percentage of Jews deported. Kuper challenges Holland's historical amnesia and uses soccer -- particularly the experience of Ajax, a club long supported by

Amsterdam's Jews -- as a window on wartime Holland and Europe. Through interviews with Resistance fighters, survivors, wartime soccer players and more, Kuper uncovers this history that has been ignored, and also finds out why the Holocaust had a profound effect on soccer in the country. Ajax produced Cruyff but was also built by members of the Dutch resistance and Holocaust survivors. It became a surrogate family for many who survived the war and its method for producing unparalleled talent became the envy of clubs around the world. In this passionate, haunting and moving work of forensic reporting, Kuper tells the breathtaking story of how Dutch Jews survived the unspeakable and came to play a strong role in the rise of the most exciting and revolutionary style of soccer -- "Total Football" -- the world had ever seen.

Football in Southeastern Europe

This volume draws together scholarship across a number of disciplines – history, sociology, media and cultural studies, political science, Slavonic Studies – to examine the significance of the sport of football within Southeastern Europe, with an especial focus on countries of the former Yugoslavia. Football's Great War

In 1915, the FA banned the payment of players, reopening a decades-old dispute between the game's early amateur values and its modern links to the world of capital and lucrative entertainment. Wartime football forced supporters to consider whether the game should continue, and if so, in what form? Using an array of previously unused sources and images, this book explores how players, administrators and fans grappled with these questions as daily life was continually reshaped by the demands of total war. From grassroots to elite football, players to spectators, gambling to charity work, this study examines the social, economic and cultural impact of what became Football's Great War.

The UEFA European Football Championships

This book explores social and political issues and trends emerging around the UEFA European Football Championships. It presents a contemporary sociology of the European Championships which, despite its significance as a mega-event, has been largely overshadowed by the Olympics and the FIFA World Cup in existing literature. At a time when both sport mega-events and Europe are undergoing dramatic transformations, this book explores a range of case studies and important topics such as changing consumption patterns, new types of sport media, social media, environmental policies and emergency politics, public opposition and co-hosting. It also situates the European Championships within wider European projects and discourses of European identities, integration and enlargement. Drawing on data from recent and historical European Championships, and looking ahead to the next tournament in Germany in 2024, this book serves to open up new debates within the sociology of sport and the study of mega-events. It is a timely and ground-breaking text which will resonate with students, academics and readers who are interested in football, the sociology of sport, megaevents, digital sociology, European politics and culture or sports business.

Women, Football and Europe

It is undeniable that Association football is a global game with huge popularity. Yet what is known as 'women's football' receives far less support, financial assistance, media coverage and academic attention than the men's game. Consequently the story of women's football remains largely untold and its potential as a sports-related discussion is yet to be fulfilled. COVID-19 and the Soccer World

The spread of COVID-19 and the consequent pandemic since early 2020 have brought about unprecedented changes in all spheres of global life, creating a new sense of (in)security with social distancing, physical isolation, quarantine and lockdown becoming buzzwords to combat the disease.

As in all spheres of life, the first wave of the pandemic posed serious challenges to the world of soccer, with diverse and intriguing responses across the globe. This book documents the early impressions and initial responses of various stakeholders of the soccer world to the challenges of COVID-19 in 2020. It reveals how the process of confrontation, negotiation, adjustment and overcoming against such challenges necessitated and inspired novel responses and strong improvisations from soccer bodies to players, referees to spectators, and journalists to sponsors. This process has revealed abrupt as well as radical changes in the organization, rules, spectatorship and telecast of the game, thereby affecting the game's cultural dimensions, commercial prospects and political implications. The volume points out that the way soccer has adjusted to the 'new normal' standard of the 'COVID Regime' has elicited newer meanings and nuanced representations of the game. The chapters in this book were originally published as a special issue of the journal, Soccer & Society.

Athletics in the Nordic Countries

In the edited collection Athletics in the Nordic Countries, scholars from Denmark, Finland, Norway, and Sweden explore historical developments and current phenomena in the sport of athletics (track and field). The chapters provide insight into sport officials, events, and athletes from the Nordic countries that have shaped the international athletics scene. The authors identify the leading role of sport leaders from Scandinavia in the foundation years and highlight how athletics' events held in the region were milestones in the transformation of the sport. Athletics' international governing body World Athletics was founded in Sweden in 1912 as the International Amateur Athletic Federation. Seventy years later, Finland hosted the first World Athletics Championships in Helsinki in 1983. In between those turning points, Nordic officials and athletes promoted significant changes in athletics, and their innovative approaches continue to shape the development of the sport until today.

Football Players in Focus

This volume investigates the way in which football supporters around the world express themselves as followers of teams, whether they be professional, amateur or national. Football Fans Around the World

'I was 12th man for England against Wales at Wembley. Within a few minutes, the Welsh half-back broke his collar bone. They had no reserves and I as the only spare player to hand. That's how I made my international debut - for Wales.' - Stan Mortensen, Blackpool and England. When Britain declared war on Germany in September 1939, football came to an abrupt halt. Large crowds were banned, stadiums were given over to military use, most players joined up. Then it was realised that if victory was the national goal, soccer could help - and football went to war. For the next six years the game became hugely important to Britain. Boosting morale among servicemen, munitions workers and beleaguered citizens alike - and raising hundreds of thousands of pounds for war funds. It was a game with plenty of human stories. Some footballers were dubbed 'PT commandos' or 'D-Day dodgers'. Others, however, saw action. Pre-war heroes on the pitch became wartime heroes off it. This book captures the atmosphere of the time and tells the story of a unique period in football's history.

Gas Masks for Goal Posts

Sports in American History, 2E

In the modern era, sport has been an important agent, and symptom, of the political, cultural and commercial pressures for convergence and globalization. In this fascinating, inter-disciplinary study, leading international scholars explore the making of modern sport in Europe, illuminating sport and its cultural and economic impacts in the context of the supra-state formations and global markets that have re-shaped national and trans-national cultures in the later twentieth century. The book focuses on the emergence and expansion of media markets, high-performance sport's transformation by, and effects upon, Cold War dynamics and relations, and the implications of the Treaty of Rome for an emerging European identity in sport as in other areas (for example, the influence of soccer's governing body in Europe, UEFA, and its club and international competitions). It traces the connections between the forces of ideological division, economic growth, leisure consumption, European integration and the development of European sport, and examines the role of sport in the changing relationship between Europe and the US. Illuminating a key moment in global cultural history, this book is important reading for any student or scholar working in international studies, modern history or sport.

Contested Fields

Sport during Cold War has recently begun to be studied in more depth. Some scholars have edited a book about the US and Soviet sport diplomacy and show how the government of these two countries have used sport during this period, notably as a tool of "soft power" during the Olympic games. Our goal is to continue in this direction and to focus more on the sport field as a place of exchanges during the Cold War. Regarding this point, our aim is to show that there were events "beyond boycotts" many and that unknown connections existed inside sport. Moreover, many actors were involved in these exchanges. Thus, it is important not only to focus on the action of States, but also on private actors (international sporting bodies and journalists), considering that they acted around sport (an "apolitic" field) as it was a tool to maintain links between the two blocs. Our project offers a good opportunity for young scholars to present original research based on new materials (notably the use of institutional or personal archives). Moreover, it is also a step forward with a view to conducting research within a global history paradigm, one that is still underused in sport academic fields.

Sport and the Transformation of Modern Europe

This book explores the tradition of left wing political thinking in the culture of fans of professional football in Europe. It sets out to chronicle and celebrate the fraternal, communal and radical tradition of football - seen to best effect in demands for democratic fan ownership and control of clubs, in fan campaigns against racist and fascist mobilisation of football supporters, and in a firm commitment to anti-corporatism. Drawing on the rich and varied traditions of fan cultures across Europe, the book examines how football, as a cultural form, carries with it the possibility of promoting the voices of the disenfranchised and the marginalised, and so the basis for nurturing solidarity against oppression, alienation and exploitation current in modern capitalist society. Political Transformation and Changing Identities in Central and Eastern Europe

Why did Franco's Spain refuse to play against the USSR? Which matches have gone beyond the sporting stakes to become a geopolitical war? Which confrontations are impossible between certain countries, like the one between Russia and Ukraine? Or conversely, how can soccer be a tool for emancipation? In a pleasant and clear style, the author tells us 22 unusual stories to understand the world. In a few years, many people will say that they started to be interested in geopolitics through Kévin Veyssière's soccer stories, after having realized that geopolitics is not boring and uninteresting, nor is it reserved for seasoned diplomats and staff officers. Kévin Veyssière, 30, is an expert and professor in geopolitics and sports. He was a parliamentary collaborator at the National Assembly in France between 2017 and 2022. He is the author of *Mondial, Soccer Club Géopolitics. 22 Unusual Stories about the Football World Cup* (Max Milo, October 2022). The author is the creator of the website FC Géopolitics, which has popularized the geopolitics of soccer. His Twitter account has more than 50,000 followers. 150,000 people a day read his articles.

Beyond Boycotts

Football in Central-Eastern and Eastern Europe has long functioned as a carrier of the three "non-normal" socio-political drivers that were effective below the surface of modernity, including the official self-image of European political systems, since the second half of the 20th century: Tribal Politics, Imaginal Politics, and Contextual Politics. All three are trends that are currently surfacing prominently on an international and global level. Long before the return of the now proverbial "Political Tribes" by the means of populisms and neo-authoritarianisms in societies around the world, football in Central-Eastern and Eastern Europe worked as a subconscious vehicle of group instincts and political moods that represented, mirrored, informed and influenced political behavior and governmental decisions both in the post-WWII communist and then, after 1989, the neo-capitalist societies located east of the former iron curtain. Football has always been used by both governments and their opponents, including the dissident civil society, to further coherence and to symbolically represent specific readings of power relations, system ideologies and history. Football in Central and Eastern Europe was always able to attract and include large parts of the population, inducing them to symbolically express protest against the government or to sustain the "politics from above". Through football politics, aspects of the area's specific political mechanisms are introduced and explained.

Fan Culture in European Football and the Influence of Left Wing Ideology

The Second World War left Europe in chaos. Landscapes had been ravaged, entire cities razed and more than 35 million people killed. Across most of the continent, the institutions that we now take for granted - such as the police, the media, transport, local and national government - were either entirely absent or hopelessly compromised. Crime rates soared, economies collapsed, and the European population hovered on the brink of starvation. In this groundbreaking study of the years that followed the war, Keith Lowe describes a continent still racked by violence, where large sections of the population had yet to accept that the war was over. He outlines the warped morality and the insatiable urge for vengeance that were the legacy of the conflict. He describes the ethnic cleansing and civil wars that tore apart the lives of ordinary people from the Baltic Sea to the Mediterranean, and the establishment of a new world order that finally brought stability to a shattered continent. These were themes, he shows, that existed across the whole of Europe - east and west. Based on original documents, interviews and scholarly literature in eight different languages, *Savage Continent* is a window on the brief, chaotic period between the end of World War II and the beginning of the Cold War. It is the first major history of the period in any language.

Soccer club geopolitics

The UEFA Champions League is an annual club football competition organized by the Union of European Football Associations (UEFA). It was first introduced in 1955, as the European Cup, and later renamed as the UEFA Champions League in 1992. The competition features 79 teams from 54 UEFA member countries. It is considered the most prestigious club competition in the world, as the best club teams from Europe compete to win the title. To qualify for the tournament, clubs must earn their place through their domestic league position or by winning a domestic cup competition. The competition consists of a group stage followed by knockout rounds, with the winner of the final being crowned the Champions of Europe. Teams such as Real Madrid, Barcelona, and Bayern Munich are among the most successful clubs in the history of the competition, with each club winning the tournament multiple times. The tournament is watched by millions of football fans around the world and generates significant revenue for UEFA and participating clubs.

Football Politics in Central Europe and Eastern Europe

Panenka's pearl of a penalty in Belgrade, van Basten's volley of a lifetime in Munich, Gazza's agonising near-miss at Wembley: over its six decades, the UEFA European Championship has thrown up many of the most memorable stories in football lore. Now it gets the history it deserves. *Euro Summits* is the first full retelling of the tournament, from its tentative beginnings in the late 1950s to its elephantine expansion in the mid-2010s. Taking in the USSR's early success, the grim violence of 1968, France's cavalier feats on home soil in 1984, the sensational triumphs of no-hopers Denmark and Greece, Spain's modern-day dominance, all the way up to Portugal's shock victory in 2016, it's a panoramic portrait of an event that captures a whole continent's imagination every four years. Dramatic, detailed and teeming with compelling personalities like Michel Platini, Guenter Netzer, Hristo Stoichkov, Zinedine Zidane, Wayne Rooney and Cristiano Ronaldo, this is the complete story of a footballing event second only to the World Cup.

Savage Continent

Over the past decade, European football has seen tremendous changes impacting upon its international framework as well as local traditions and national institutions. Processes of Europeanization in the fields of economy and politics provided the background for transformations of the production and consumption of football on a transnational scale. In the course of such rearrangements, football tournaments like the UEFA Championship or the European Champions League turned into mega-events and media spectacles attracting ever-growing audiences. The experience of participating in these events offers some of the very few occasions for the display and embodiment of identities within a European context. This volume takes the 2008 EUROS hosted by Austria and Switzerland as a case study to analyze the political and cultural significance of the tournament from a multidisciplinary angle. What are the special features and spatial arrangements of a UEFAesque Europe, in comparison to alternative possibilities of a Europe? Situating the sport tournament between interpretations of collective European ritual and European spectacle, the key research question will ask what kind of Europe was represented in the cultural, political and economic manifestations of the 2008 EUROS. This book was published as a special issue of *Soccer and Society*.

Introduction to UEFA Champions League

European Football is Black and White offers an engaging interpretation of a disturbing phenomenon in Europe's favorite sport: football violence fueled by racism. While many fans across Europe have used football to further destructive, ethnocentric agendas, there are also Europe-wide initiatives in the football stadium to combat the almost endemic problem. Christos Kassimeris analyses political ideologies that have influenced football supporters, drawing attention to the increasing politicization of football and the footballization of politics. He also considers the contributions of nationalism, social class, and media coverage before assessing attempts by various groups, from the Football Against Racism in Europe (FARE) network to the European Union itself, to rectify the problem. Ultimately, football needs to be dissociated from both racism and politics for the sport to flourish. Unlike more traditional attempts to explain the football violence and racism, this book seeks to establish a Europe-wide as well as national explanatory framework for this racism from a political perspective. This study will draw the interest not only of scholars across the Humanities and Social Sciences, but also of ordinary football supporters.

Euro Summits

Europe is a continent whose history has, in one form or another, long been dominated by integration. And yet the European integration process is often treated as synonymous with the evolution of just one particular, and until recently geographically quite limited, Western-centred organisation: the European Union (EU). Living apart can be tolerated, but divorce is unacceptable. To save the Welland family's reputation, a law partner of Newland asks him to dissuade Countess Olenska from divorcing the count. He succeeds, but in the process comes to care for her; afraid of falling in love with Ellen, Newland begs May to accelerate their wedding date, but she refuses. Newland tells Ellen he loves her; Ellen corresponds, but is horrified that their love will aggrieve May. She agrees to remain in America, separated but still married to Count Olenski, only if they do not sexually consummate their love. Newland receives May's telegram agreeing to wed sooner. Newland and May marry. He tries unsuccessfully to forget Ellen. His society marriage is loveless, and the social life he once found absorbing has become empty and joyless. Though Ellen lives in Washington and has remained distant, he is unable to cease loving her. Their paths cross while he and May are in Newport, Rhode Island. Newland discovers that Count Olenski wishes Ellen to return to him, but she has refused, although her family wants her to reconcile with her husband and return to Europe. Frustrated by her independence, the family has cut off her money, as the count had already done. Newland desperately seeks a way to leave May and be with Ellen, obsessed with how to finally possess her. Despairing of ever making Ellen his wife, he urges her to become his mistress. Then Ellen is recalled to New York City to care for her sick grandmother, who accepts her decision to remain separated and agrees to reinstate her allowance. Back in New York and under renewed pressure from Newland, Ellen relents and agrees to consummate their relationship. However, Newland then discovers that Ellen has decided to return to Europe. Newland makes up his mind to abandon May and follow Ellen to Europe when May announces that she and Newland are throwing a farewell party for Ellen. That night, after the party, Newland resolves to tell May he is leaving her for Ellen. She interrupts him to tell him that she learned that morning that she is pregnant; she reveals that she had told Ellen of her pregnancy two weeks earlier, despite not being sure of it at the time. The implication is that she

did so because she suspected the affair. Newland guesses that this is Ellen's reason for returning to Europe. Hopelessly trapped, Newland decides not to follow Ellen, surrendering his love for the sake of his children, remaining in a loveless marriage to May. Twenty-six years later, after May's death, Newland and his son are in Paris. The son, learning that his mother's cousin lives there, has arranged to visit Ellen in her Paris apartment. Newland is stunned at the prospect of seeing Ellen again. On arriving outside the apartment building, Newland sends up his son alone to meet Ellen, while he waits outside, watching the balcony of her apartment. The Governance of Criminal Justice in the European Union

Professor Fischer presents a comprehensive overview of global trade at the start of a new century, from a national, regional, and international viewpoint. He looks closely at the four dominant and competing economic systems—the United States, the European Union, Japan, and China—and argues that the traditional we-win/you-lose national trade paradigm has been replaced by one that is more collaborative, one that is leaning toward de facto world governance. All these factors raise important global questions, among them: Can American capitalism prevail? Should the United States proceed unilaterally, as it has so often? Or are regional and multinational arrangements preferable? If there is further globalization, as seems inevitable, and if American influence is on the wane, what group or organization will lead? To explore these questions and provide the beginnings of answers, Professor Fischer uses his four competing economic systems and handicaps the process country by country, sector by sector, with particular attention to transatlantic relations.

Broken Country Broken Soldier

"Nothing in my army training had prepared me for what happened in Jerusalem in February 1965." In Chris McQuaid's stunning memoir, *Elegy for a Broken Soldier*, a traumatic event led to his Post-Traumatic Stress Disorder (PTSD). Music became the only respite that provides him solace. Chris was a member of the Irish Army guard of honour for the visit of US President John F. Kennedy to Dublin in June 1963. With the cheers of the crowds lining the presidential route still ringing in his ears, he felt "ten feet tall" as he prepared for his first UN peacekeeping mission to the Congo. On a UN mission to Cyprus in 1965, trauma changed Chris's life forever, marking the beginning of his PTSD. In Lebanon in 1980, his life was threatened, and the shock effectively ended his military career. Neither event originated on the battlefield, but from within the Irish Army. Despite severe depression and suicidal thoughts, Chris continued his education and returned to the service to become a commissioned officer. He left the army in 1986 with a glowing service record. A long legal wrangle and a succession of psychiatric and psychological assessments have led to even greater health problems, but Chris has survived it all.

Elegy for a Broken Soldier

In a time of crisis we start grasping for straws on what to do. Some seek wise counsel while others go gung ho to take on a role of a hero and attempt to handle the situation themselves. Caught in a losing fight for survival, these brave soldiers who were giving their all for what they believed in found a fate of one that might have belonged to a third world country with morals that could be counted on one finger.
