This organization changed in 1947 when the new United States Air Force adopted the wing-base plan. Each combat group then active received a controlling parent wing of the same number and nomenclature. The new wing also controlled three additional groups with the same number to operate the air base, maintain the aircraft, and provide medical care at the base. When combat forces began to fight the war in Korea, the USAF units did so in various organizational forms. In 1951, the Strategic Air Command began to eliminate its combat groups by reducing the group headquarters to token strength and attaching the flying squadrons directly to the wing; therefore, wings replaced the medium bombardment groups attached to Far East Air Forces (FEAF) Bomber Command for combat. The groups were either inactivated or reduced in strength to one officer and one enlisted. In most cases, the personnel assigned to the group headquarters were simply reassigned to the wing headquarters, which had moved on paper to the location of the group headquarters. Most other combat organizations in-theater continued to operate with both wing and group headquarters or with group headquarters only. In a few cases, individual squadrons, such as the 319th Fighter-Interceptor Squadron, were directly controlled by an organization higher than either wing or group level.

Down in the Weeds

The anthology of articles that follows was compiled by the History and Museums Division during the 50th Anniversary commemoration of the Korean Conflict, 1950-1953. The focus of the various authors who wrote these historically related works on Korea did so to remember those Marines who fought and died in what some historians sometimes characterized as the "forgotten war." Forgotten or not, the Korean conflict was without parallel in Marine Corps history and no one who experienced it or lived through this era could ever forget the difficulties that they would encounter there. The Korean War also represented a milestone in the developmental history of the Marine Corps. For perhaps what could very well be the last time, the Marine Corps made an opposed World War II style amphibious landing against a dedicated enemy. Korea was also the opening salvo in what became known as the Cold War. In reality, Korea represented the beginning of a series of "limited wars" that would be fought by the United States with the express political purpose of keeping such conflicts from developing into full blown world wars. Frustratingly for the men and women in uniform during the Cold War, political considerations frequently overrode military exigencies and logic. Having just successfully concluded a total war against an enemy whose objectives were clearly identifiable, the Korean conflict proved fraught with political twists and turns that made the military's job immensely more difficult. This was especially evident during the "stalemate" phase of the war, 1952-1953. No less bloody or violent, this period of the conflict saw the Marine Corps incur a significant number of casualties. The Korean conflict was also important for operational reasons. It was clear that from 1950 on, limited wars fought by U.S. forces would be largely "come as you are affairs." During the summer and early fall of 1950, the Marine Corps learned a valuable lesson when it had to scramble to assemble its landing force for the Inchon operation, getting the 1st Marine Division into theater in the nick of time. No longer would the United States have the luxury of time in getting forces ready for limited wars. Next, for the first time, the advent of the helicopter would play a significant role in the combat plans of Marine units in the field. Experimentation with the concept of vertical assault, using this new technology took place during the conflict. Korea would also be the first time Marines would be given personal body armor or "flak jackets" to wear in combat. Such body armor would come in handy as the war settled into a stalemate

along the 38th Parallel. While Marine elements had deployed to extremely cold locations in the past such as the occupation of Iceland by the 1st Marine Brigade (Provisional) in 1941, Korea would be the first time in the modern era where the Marine Corps would have to fight in extremely cold conditions. During Korea, the Corps came away with a new appreciation for the necessity of having the proper environmental gear tested and available for use by its combat and combat support troops. In sum, Korea set the operational tone that the Marine Corps would follow for the rest of the Cold War.

Each brief in section two contains an operational summary of a given organization's activities in the war, but specific information in the Chronology is not repeated here. The commanders of groups and wings are listed next, and where applicable, Korean War campaign streamers, Korean War decorations, and Medal of Honor recipients are identified. The organizations' official emblems at the time of the Korean War appear with their descriptions or blazons. The third part of the manuscript contains the available official lists of Air Force units and organizations located in Korea, extracted directly from the bimonthly publication, Directory of USAF Organizations, issued by HQ USAF DCS/Comptroller. These listings date from July 1, 1950, which showed no USAF unit or organization located in Korea, to July 1, 1953, which listed stations and organizations located in Korea just before the end of the conflict. Unfortunately, we were not able to locate two issues of this series - May 1, 1951, and July 1, 1951. The issue of April 1952 was a special edition; then, the series reverted to bimonthly issues. These lists appear exactly as shown in the directories. The data contained in each issue reflects information provided by FEAF and other commands to the HQ USAF, Directorate of Statistical Services, Machine Accounting Division, through the end of the previous month. In some instances, the inputs did not specifically identify the location of an organization, leaving the reader to guess whether an organization was located in the town or at a nearby air base or airdrome. Rendering Korean place names in English inevitably results in a variety of spellings, and these lists are no exception. For example, the location generally known in USAF documents as Kangnung is in these lists consistently spelled as Kangnumg. The final section is a listing, both numerically and alphabetically, of locations in Korea identified as K-Sites. The place name spellings used are those found in Fifth Air Force general orders designating the K-Sites and other official Fifth Air Force documents. Also included is a map of Korea that approximately locates each K-Site.

North Korean and Chinese forces infiltrated thinly held American lines to ambush units on the move or assault battery positions from the flanks or rear with, all too often, the same disastrous results. Trained to fight a linear war in Europe against conventional Soviet forces, field artillery units were unprepared for combat in Korea, which called for all-around defense of mutually supporting battery positions, and high-angle fire. Ironically, these same lessons had been learned the hard way during recent fighting against the Japanese in a 1944 action on Saipan, not Korea, aptly demonstrates. Korea

Before the Korean War, the primary mission of Lt. Gen. George E. Stratemeyer's Far East Air Forces was air defense of the Japanese homeland. Most of the aircraft constituting Stratemeyer's inventorywere interceptors, not designed for the type of combat that would be required now that the United States was joining in the UN effort toend the war in Korea. The Joint Army/USAAF doctrine of 1946, known as Field Manual 31-35, Air Ground Operations, was also considered outdated in the present circumstance. A new approach to war fighting had to be developed in response to the strong influence of General Douglas MacArthur and other of his air officers in the Army-dominated General Headquarters Far East Command. Close air support of the ground forces as provided by Fifth Air Force came at some cost, and tempers flared in the process, but the air commanders in Korea never deprived the ground commanders of close air support if it was needed. Indeed, without the close air support provided to the airmen, the ground campaign would have been a much more bloody and difficult affair than it was. This book tells the story.

Forgotten Warriors

More than 60 years since the outbreak of war on the Korean Peninsula, the United States Armed Forces continue to stand by the soldiers, sailors, airmen, and marines of the Republic of Korea in an effort to deter further North Korean aggression. The purpose of this monograph is capture operational lessons learned during the Korean War that should be taken into consideration by operational planners as they prepare for future conflict on the peninsula. Looking at the Korean Peninsula's geography, weather and terrain, and place in the world highlight unique challenges operational planners will face. The strategic context of North Korea's proximity and alliance to China is important to understand and take into consideration during any operation in the region. China considers North Korea as a buffer protecting its region of Manchuria. Encroachment of this border by foreign forces is a threat to Chinese sovereignty. China's continued support of the North Korean regime is essential to their survival and must always frame the operational environment. The Korean Peninsula is subject to weather extremes, such as monsoons and harsh winters that have a direct impact on operations. During the winter of 1950-1951, marines and soldiers faced sub-zero temperatures and heavy snowfall that blocked mountain passes and clogged main supply routes. Fifty years later, soldiers and airmen serving in Korea experienced another such harsh winter that limited operations because of heavy snowfall and had an impact their ability to respond to threats from the north. The reason that weather has such an operational impact is because of the restrictive terrain found on the peninsula. The Korean Peninsula is primarily mountainous, with most valleys running north to south, and having limited east west cross mobility corridors. In the north, limited infrastructure, such as road networks and expressways, compounds the problem. Add to this, population centers based around crossroads along the valley floors, and the terrain becomes even more restrictive to ground maneuvers. By examining combat operations during the Korean War, it becomes apparent that operational planners must consider force structure. The allocation of force multipliers to enable independent brigade operations without the possibility of

mutually supporting maneuver units is critical in Korea's restrictive terrain. A look at the terrain and weather found on the peninsula, along with a short history of Korea, sets the stage for a look at the Korean War. Following United Nations forces through their first year of fighting through the lens of operational art highlights relevant lessons learned for the operational planner. Couching these lessons learned in the Korean environment of today, establishes a framework that is useful for operational planners.

Operational Lessons Learned in the Korean War

Despite American success in preventing the conquest of South Korea by communist North Korea, the Korean War of 1950-1953 did not satisfy Americans who expected the Kind of total victory they had experienced in World War II. In that earlier, larger war, victory over Japan came after two atomic bombs destroyed the cities of Hiroshima and Nagasaki. However, in Korea five years later, the United States limited itself to conventional weapons. Even after Communist China entered the war, Americans put China off-limits to conventional bombing as well as nuclear bombing. Operating within these limits, the U.S. Air force helped to repel two invasions of South Korea while securing control of the skies so decisively that other United Nations forces could fight without fear of air attack. The book also helps explain why even unsuccessful insurgencies have survived for decades, as has happened in Colombia and Peru. It focuses on expectations concerning the impact of air power on the ground war and on some of its actual effects, but it avoids major treatment of some of the most dramatic air actions of the war, such as the bombing of Hanoi. To many who fought the war and believe it ought to have been conducted on a still larger scale or with fewer restraints, this study may seem almost perverse, emphasizing as it does the utility of air power in conducting the conflict as a ground war and without total exploitation of our most awe-inspiring technology. Although the chapters in this study are intended to form a coherent and unified argument, each also offers discrete messages. The chapters are not meant to be definitive. They do not exhaust available documentary material, and they often rely heavily on published accounts. Nor do they provide a complete chronological picture of the uses of air power, even with respect to the ground war. Nor is coverage of areas in which air power was employed—South Vietnam, Laos, Cambodia, and North Vietnam—evenly distributed nor necessarily proportionate to the effort expended in each place during the war. Lastly, some may find one or another form of air power either slightly or insufficiently treated. Such criticisms are beside the point, for the objectives of this study are to explore a comparatively neglected theme—the impact of air power on the ground—and to encourage further utilization of lessons drawn from the Vietnam experience.

Air Power And The Ground War In Vietnam, Ideas And Actions

Hybrid warfare has been an integral part of the historical landscape since the ancient world, but only recently have analysts - incorrectly - categorised these conflicts as unique. Great powers throughout history have confronted opponents who used a combination of regular and irregular forces to negate the advantage of the great powers' superior conventional military strength. When Brigadier General Sherwood Lett arrived in Vietnam over a decade before American troops, he and the Canadians under his command risked their lives trying to enforce an unstable peace while questioning whether they were merely handmaidens to a new war. As American battleships steamed across the Pacific, Canadian diplomat Blair Seaborn was meeting secretly in Hanoi with North Vietnam's prime minister; if American leaders accepted his roadmap to peace, those ships could be turned around before war began. Claire Culhane worked in a Canadian hospital in Vietnam and then returned home to implore Canadians to stop supporting what she deemed an immoral war. Joe Erickson was among 30,000 young Americans who changed Canada by evading the draft and heading north; Doug Carey was one of the 20,000 Canadians who enlisted with the American forces to serve in Vietnam. Rebecca Trinh fled Saigon with her husband and young daughters, joining the waves of desperate Indochinese refugees, thousands of whom were to forge new lives in Canada. Through these wide-ranging and

fascinating accounts, Boyko exposes what he calls the Devil's wiliest trick: convincing leaders that war is desirable, persuading the public that it is acceptable, and telling combatants that the deeds they carry out and the horrors they experience are normal, or at least necessary. In uncovering Canada's side of the story, Boyko reveals the many secret and forgotten ways that Canada not only fought the war but was forever shaped by its lessons and lies.

The Devil's Trick

From South Carolina to South Vietnam, America's two hundred-year involvement in guerrilla warfare has been extensive and varied. America and Guerrilla Warfare analyzes conflicts in which Americans have participated in the role of, on the side of, or in opposition to guerrilla forces, providing a broad comparative and historical perspective on these types of engagements. Anthony James Joes examines nine case studies, ranging from the role of Francis Marion, the Swamp Fox, in driving Cornwallis to Yorktown and eventual surrender to the U.S. support of Afghan rebels that hastened the collapse of the Soviet Empire. The American experience in Vietnam was a debacle but, according to Joes, profoundly atypical of the country's overall experience with guerrilla warfare. He examines several twentieth-century conflicts that should have better prepared the country for Vietnam: the Philippines after 1898, Nicaragua in the 1920s, Greece in the late 1940s, and the Philippines again during the Huk War of 1946-1954. Later, during the long Salvadoran conflict of the 1980s, American leaders seemed to recall what they had learned from their experiences with this type of warfare. Guerrilla insurgencies did not end with the Cold War. As America faces recurring crises in the Balkans, sub-Saharan Africa, the Middle East, and possibly Asia, a comprehensive analysis of past guerrilla engagements is essential for today's policymakers.

The Vietnam War

Immediately after its founding by HÓ Chí Minh in September 1945, the Democratic Republic of Vietnam (DRV) faced challenges from rival Vietnamese political organizations and from a France determined to rebuild her empire after the humiliations of WWII. HÓ, with strategic genius, courageous maneuver, and good fortune, was able to delay full-scale war with France for sixteen months in the northern half of the country. This was enough time for his Communist Party, under the cover of its Vietminh front organization, to neutralize domestic rivals and install the rough framework of an independent state. That fledgling state became a weapon of war when the DRV and France finally came to blows in Hanoi during December of 1946, marking the official beginning of the First Indochina War. With few economic resources at their disposal, HÓ and his comrades needed to mobilize an enormous and free contribution in manpower and rice from DRV-controlled regions. Extracting that contribution during the war's early days was primarily a matter of patriotic exhortation. By the early 1950s, however, the infusion of weapons from the United States, the Soviet Union, and China had turned the Indochina conflict into a "total war." Hunger, exhaustion, and violence, along with the conflict's growing political complexity, challenged the DRV leaders' mobilization efforts, forcing patriotic appeals to be supplemented with coercion and terror. This trend reached its revolutionary climax in late 1952 when HO, under strong pressure from Stalin and Mao, agreed to carry out radical land reform in DRV-controlled areas of northern Vietnam. The regime's 1954 victory over the French at iCn Biên Phc, the return of peace, and the division of the country into North and South did not slow this process of socialist transformation. Over the next six years (1954–1960), the DRV's Communist leaders raced through land reform and agricultural collectivization with a relentless sense of urgency. Mass Mobilization in the Democratic Republic of Vietnam, 1945–1960 explores the way the exigencies of war, the dreams of Marxist-Leninist ideology, and the pressures of the Cold War environment combined with pride and patriotism to drive totalitarian state formation in northern Vietnam.

Where the Domino Fell

In 1964 the Viet Cong was firmly entrenched in the Mekong Delta region. Using fear and terror tactics, the insurgency gained control of the population creating a safe haven for the movement to thrive and expand. The United States and the Government of South Vietnam recognized the infiltration problem in the Mekong Delta but their military organizations were either unable or incapable to deal with the problem. The geography of the region made it impossible for a U.S. Army or Marine Corps division to operate effectively and the South Vietnamese Army and Navy lacked the training and equipment to operate successfully. In response to these obstacles, Secretary of Defense, Robert McNamara, commissioned the U.S. Navy to develop a fighting force capable of operating in the delta and ridding the region of the Viet Cong influence. The Navy used for main Operations: MARKET TIME, GAME WARDEN,-The Mobile Riverine Force, and SEALORDS to achieve these goals. In four short years the Brown Water Sailors experienced marked success with Viet Cong influence minimized and resupply efforts rerouted to the tortuous Ho Chi Minh Trail. However, by the end of 1968 American resolve to fight a war in South Vietnam had deteriorated and the Government needed a way out. President Nixon's Vietnamization program provided the exit for American forces and in turn mitigated the Brown Water Navy's successes of the previous four years. The Brown Water Navy overcame tremendous obstacles in less than one year to create and deploy a formidable fighting force to the Mekong Delta. In four years aggressive strides against the Viet Cong insurgency were achieved only to be mitigated by the effects of Vietnamization.

The Dynamics of Military Revolution, 1300-2050

For imperialists, the concept of guardian is specifically to the armed forces that kept watch on the frontiers and in the heartlands of imperial territories. The book explains the political and military pressures which drove successive French governments to widen the scope of French military operations in Algeria between 1954 and 1958. It also explores gender issues and African colonial armies.

Finding the manpower to defend democracy has been a recurring problem. Russell Weigley writes: The historic preoccupation of the Army's thought in peacetime has been the manpower question: how, in an unmilitary nation, to muster adequate numbers of capable soldiers quickly should war occur. When the nature of modern warfare made an all-volunteer army inadequate, the major Western democracies confronted the dilemma of involuntary military service in a free society. The core of this manuscript concerns methods by which France, Great Britain, and the United States solved the problem and why some solutions were more lasting and effective than others. Flynn challenges conventional wisdom that suggests that conscription was inefficient and that it promoted inequality of sacrifice. Sharing similar but not identical diplomatic outlooks, the three countries discussed here were allies in world wars and in the Cold War, and they also confronted the problem of using conscripts to defend colonial interests in an age of decolonization. These societies rest upon democratic principles, and operating a draft in a democracy raises several unique problems. A particular tension develops as a result of adopting forced military service in a polity based on concepts of individual rights and freedoms. Despite the protest and inconsistencies, the criticism and waste, Flynn reveals that conscription served the three Western democracies well in an historical context, proving effective in gathering fighting men and allowing a flexibility to cope and change as problems arose.
