Terminologie et interdisciplinarité

Souvent, les projets interdisciplinaires sont une juxtaposition d'approches denuees d'articulation. Ce manque d'integration est lie pour une part a des problemes de vocabulaire. Aussi, le CTB (Centre de terminologie de l'Institut Libre Marie Haps) et l'AEPL (Association europeenne des linguistes et des professeurs de langues) ont-ils reuni des scientifiques, des techniciens et des terminologues pour un colloque sur l'interdisciplinarite. L'enseignement des langues étrangères dans les pays de l'Union européenne

Si, au fur et a mesure que l'Union Europeenne s'elargit et son importance au niveau mondial s'accroit aussi bien du point de vue territorial que demographique, economique et politique, l'introduction de nouvelles langues officielles pose un probleme linguistique majeur; celui de la communication entre Etats, entre citoyens. L'Union Europeenne, en decidant de garder onze langues officielles, a fait le pari de la complementarite des langues, le pari de la diversite. Mais, l'option de la diversite a aussi ses exigences. C'est pour repondre a cette question que nous avons trouve utile d'entreprendre une recherche a l'echelle europeenne, dont les resultats sont presentes dans cet ouvrage.

Temps et discours

Les articles reunis dans ce volume explorent trois aspects des rapports entre le temps et le discours: la reference temporelle, le rapport entre le type de discours et l'emploi des temps verbaux et les manifestations discursives du developpement du systeme temporel au cours de l'acquisition. La reference temporelle, exprimee par les tiroirs verbaux et par certains connecteurs temporels, constitue un aspect important de la temporalite traite dans ce volume. Le verbe grec ancien

Cette deuxieme edition, entierement revue et augmentee, tient compte des nouveautes intervenues depuis 1991 et se distingue de la premiere par de tres nombreux changements, les uns, ponctuels, les autres, plus substantiels (plan, terminologie, etc.). Dans cet ouvrage, les etudes morphologiques et syntaxiques sont effectuees dans une optique structuraliste. Elles sont toujours menees de pair, de maniere a ce que signifiant et signifie s'eclairent mutuellement. Pour eviter le danger d'eparpiller la description linguistique en autant de categories qu'il y a d'emplois differents, l'examen syntaxique est centre non pas sur la syntaxe des propositions, mais sur chacune des composantes du systeme (voix, modes, temps, etc.) examinees dans tous leurs emplois. L'aspect verbal grec suscite encore aujourd'hui des difficultes non resolues et donne lieu a des theories contradictoires. Un traitement particulierement approfondi lui a donc ete consacre. Cette nouvelle edition aborde davantage de details

que la premiere; une question cruciale, bien que trop rarement discutee: a quels motifs repond le choix des aspects par les locuteurs? Ceci met en jeu la dynamique de la selection aspectuelle, dont il se confirme qu'elle est vraiment l'un des secteurs les plus prometteurs des etudes syntaxiques grecques anciennes. L'ouvrage fournit la frequence des temps et modes d'un corpus de plus de 100 000 formes verbales s'echelonnant depuis Homere jusqu'au IVe siecle, de meme que la liste (avec leur frequence) des 250 verbes les plus usites d'un corpus de plus de 140 000 formes verbales du IVe siecle. Il est pourvu de trois index: des passages, des formes verbales, analytique.

La Coupure invisible

La tradition avait rangé dans un tiroir à part les infinitifs dits substantivés et les adjectifs de même titre, les interjections et les mentions, et bien d'autres objets, dont l'identification catégorielle posait problème : dans le bleu du ciel bleu est-il un adjectif, est-il un nom ? Questionnement parallèle possible sur gouverner dans le gouverner autrement, ou sur diable dans Diable! On remet ces données sur le métier avec l'objectif de rendre à la syntaxe et à la morphologie dérivationnelle ce qui leur appartient, même si la coupure est invisible. En effet, un terme X qui occupe une position Y demeure-t-il un X ou devient-il un Y ? S'il conserve son identité de X, acquiert-il certaines propriétés du fait de sa position ? S'il devient un Y, le devient-il momentanément, le temps de l'emploi ? Si la nouvelle appartenance catégorielle est stable, comment la morphologie rend-elle compte de ces homonymes ? Quelle est la propriété d'occupabilité de telle position, dans telle langue ? La remise en cause du caractère endocentrique des groupes syntagmatiques, l'identification du procédé non-affixal de conversion dans la morphologie du français, tels sont les principaux résultats, ce qui a conduit à chercher à comprendre pourquoi le phénomène de dérivés non-affixés avait été soit ignoré, soit confondu avec d'autres dans le fourre- tout de la "dérivation impropre". Ainsi, outre des propositions d'analyse de données du français, ce travail comporte un essai de démythologisation d'une notion grammaticale traditionnelle.

Politesse et idéologie

Sans cesse nous posons des jugements. Aussitot que nous croyons y echapper, la scalarite des valeurs nous rejoint. Nous avons beau prendre les precautions d'usage, decrire le contexte en choisissant de paraitre complets, l'ame humaine reprend son droit: parler n'est jamais neutre. Ecouter l'est moins encore. Nous posons des jugements parce que nous interpretons et que le langage, a travers ses procedes, sa construction collective de la realite, y invite. On dira de l'un qu'il est trop poli pour etre honnete, de l'autre au contraire qu'il est trop honnete pour etre poli. C'est en effet la spontaneite qu'on interroge dans son rapport avec la reflexion. Le temps de l'ecriture contient la science, la classification mais elle perd la supreme nature. On pensait l'affaire close depuis l'avenement de l'image; voila que la projection extraordinaire du courrier electronique sur la Toile nous ramene au coeur du debat. Deja, les cris fusent pour denoncer l'impolitesse du procede.
