Only among them, in Pakistan's eastern province, now Bangladesh, was there a politically dominant coalition of classes that was friendly to the development of parliamentary democracy. It had the ironic effect in Pakistan of entrenching the west's anti-democratic coalition. Dogged by the legacies of twenty-four years as Pakistan's subordinate province, disorganization among its dominant classes and a vanished rural base, the development of parliamentary democracy in Bangladesh has been slow and uneven.

The book includes both theoretical investigations tracing the modern development of the concepts of governance, development and democratization as well as regional and country-specific observations of major issues, presenting comprehensive country-level studies of China, Singapore, Thailand, Cambodia, the Philippines, Myanmar, Fiji and the Solomon Islands. Presenting fascinating insight into non-democratic governance, civil society and the rule of law in illiberal contexts, Governance and Democracy in the Asia-Pacific will prove to be of great use to students and scholars of Asian politics and society, as well as international and comparative politics.

## South Asian Sovereignty

South Asia has had a tumultuous and varied experience with constitutional democracy that predates the recent rise in populism (and its study) in established democracies. And yet, this region has remained largely ignored by constitutional studies and democracy scholars. This book addresses this gap and presents a contribution to the South Asia-centric literature on the topic of the stability and resilience of constitutional democracies. Chapters deal not only with relatively well known South Asian countries such as India, Bangladesh, Pakistan, and Sri Lanka, but also with countries often ignored by scholars, such as Bhutan, Nepal, Maldives, and Afghanistan. Such exigencies have important implications for Indian foreign policy in South Asia. Analysing India's foreign policy through the lens of competing domestic visions at three different historical eras in India's independent history, the book provides a framework for studying India's developing nationhood on the basis of these idea(s) of 'India'. This approach allows for a deeper and a more nuanced interpretation of the motives for India's foreign policy choices than the traditional realist or neo-liberal framework, and provides a useful contribution to South Asian Studies, Politics and International Studies.

## Civil Society in Southeast Asia

## Southeast Asian Responses to Globalization

Until the 1990s, secularism was understood largely as exclusion of religion from the public domain. #### The Politics of Elections in Southeast Asia

The book maps the impact of social media and the internet on democracy in the members of the Association of Southeast Asian Nations that

Including an analysis of countries that do not have national elections, the chapters provide detailed information on the extent of internet and social media penetration in each country, the laws that are deployed to reel in its political potential for critics and demonstrate the impact on democracy or the prospects for democracy. Collectively, contributors note that disinformation is a serious problem in the region that negatively impacts elections and how governments' attempts to deal with the phenomenon inevitably lead to the targeting of dissenting voices and opposition as anti-state fake news. The deleterious impact on democracy and freedom of expression, facilitated by a citizenry that is prone to manipulation of facts, appears to be the standard modus operandi in the regional authoritarian complex. This book is the first to undertake a regional analysis of disinformation in Southeast Asia and is a significant contribution to the literature on democracy, elections and disinformation. It will be of interest to researchers in the fields of Political Science and Asian Politics, in particular Southeast Asian Politics.

#### India in South Asia

This volume provides an introduction to the politics of the five key southeast Asian states - Malaysia, Singapore, Indonesia, Thailand and the Philippines - and is intended as a textbook for undergraduate and graduate students taking courses on this subject. Using a comparative politics and political economy perspective, the author focuses in particular on the degree of democracy in the five countries, arguing that in all the countries considered democracy is, to varying degrees, imperfect. #### Federalism in South Asia

Offering an understanding of governance and development in the context of the South Asia, this book will be of interest to academics in the fields of Political Economics, International Development Studies, Political Science, and Governance Studies, as well as policy makers.
