As a result of this concern, the U.S. Congress passed the National Historic Preservation Act (NHPA), signed into law by President Johnson on 15 October 1966. NHPA created the national preservation structure that has saved untold thousands of places that make our communities richer economically, culturally, and aesthetically.
