Bile duct cancer, also known as cholangiocarcinoma, starts in a bile duct. To understand this cancer, it helps to know about the bile ducts and what they normally do. The bile ducts are a series of thin tubes that go from the liver to the small intestine. Their main job is to allow a fluid called bile to go from the liver and gallbladder into the small intestine, where it helps digest the fats in food. Different parts of the bile duct system have different names. In the liver it begins as many tiny tubes (called ductules). The ductules come together to form small tubes called ducts. These merge into larger ducts and then into the left and right hepatic ducts. All of these ducts within the liver are called intrahepatic bile ducts. The left and right hepatic ducts exit the liver and join to form the common hepatic duct in an area called the hilum. Lower down, the gallbladder (a small organ that stores bile) is joined to the common hepatic duct by a small duct called the cystic duct. This combined duct is called the common bile duct. The common bile duct passes through part of the pancreas before it joins with the pancreatic duct and empties into the first part of the small intestine (the duodenum) at the ampulla of Vater.
