Consequently, failure to comply with international law ordinarily involves greater political and economic costs than does observance. In short, States comply with international law because it is in their interest to do so. Like most rules of conduct, international law is in a continual state of development and change. Practice of StatesThe general and consistent practice among States with respect to a particular subject, which over time is accepted by them generally as a legal obligation, is known as customary international law. # U.S. Military Operations

ILMO is a distinct sub-discipline within public international law and domestic public law, covering all domains of military operations: land, sea, air and (cyber)space.
