## Erich Kästner

Für Erich Kästner stellten moralische Überzeugungen und politisches Handeln eine Einheit dar. Begründete er die Haltung in seiner Frühzeit auf der Grundlage eines moralischen Gefühls, das vor allem bei Kindern, Künstlern und Außenseitern ausgeprägt sein sollte, so wandelt sich diese Auffassung durch die Kriegserlebnisse. Nach 1945 wirkte Kästner in Literatur, Publizistik und im Rahmen seiner PEN-Club-Aktivitäten deutlich direkter politisch. Die Beiträge des Bandes versuchen, diese Entwicklung zwischen moralischer Politik und politischer Moral nachzuzeichnen. Eine Aufgabe der Beiträge besteht daher in einer präzisen Rekonstruktion des moralischen Emotionalismus Erich Kästners, den er von seiner frühen Lyrik bis zu seinen spätesten Artikeln und Solidaritätsadressen

wie selbstverständlich ausprägte und der ohne jede metaphysische Referenz auskommt. Besonders komplex gerät diese Aufgabe, weil Kästners bisweilen rigoristischer Moralismus mit den Instrumenten eines ganz eigentümlichen Humors abgefedert wird, der mehr verstärkend als entlastend wirkt.

#### Erich Kästner, Moralist mit doppeltem Boden

This is the first study of Thomas Mann's landmark German modernist novel *Der Zauberberg* (The Magic Mountain, 1924) that takes as its starting point the interest in Mann's book shown by non-academic readers. It is also a case study in a cluster of issues central to the interrelated fields of transnational German studies, global modernism studies, comparative literature, and reception theory: it addresses the global circulation of German modernism, popular afterlives of a canonical work, access to cultural participation, relationship between so-called 'high-brow' and 'low-brow' culture, and the limitations of traditional academic reading practices. The study intervenes in these discussions by developing a critical practice termed 'closer reading' and positioning it within the framework of world literature studies. Mann's *Magic Mountain* centres around nine comparative readings of five novels, three films, and one short story conceived as responses to *The Magic Mountain*. These works provide access to distinct readings of Mann's text on three levels: they function as records of their authors' reading of Mann, provide insights into broader culturally and historically specific interpretations of the novel, and feature portrayals of fictional readers of *The Magic Mountain*. These nine case studies are contextualized, complemented, enhanced, and expanded through references to hundreds of other diverse sources that testify to a lively engagement with *The Magic Mountain* outside of academic scholarship, including journalistic reviews, discussions on internet fora and blogs, personal essays and memoirs, Mann's fan mail and his replies to it, publishing advertisements, and marketing brochures from Davos, where the novel is set.

#### Gedichte zum Gebrauch

Erich Kästner hat neunzehn Kinderbücher, einige Romane für Erwachsene, Kabaretttexte, journalistische Arbeiten und eine Vielzahl an Gedichten geschrieben. In diesem Buch geht der Literaturwissenschaftler und Autor Kästners Lyrik der Jahre 1928 bis 1932 auf die Spur und vergleicht die Gedichte mit dem 1931 erschienenen Roman „*Fabian. Die Geschichte eines Moralisten*“. Beide, Lyrik wie Roman, sind bedeutende Beispiele für die Literatur der Weimarer Republik und für die Neue Sachlichkeit. Die in beiden Werken verarbeiteten Themen spannen das gesamte Kaleidoskop des damaligen Lebens während der Weltwirtschaftskrise und am Vorabend der Nazi-Diktatur auf, insbesondere das der neu entstandenen Schicht der Angestellten, die erst ihre gesellschaftliche Rolle finden mussten. Spannend, die damalige Zeit erhellend, und gnadenlos aktuell.

#### Politik und Moral

Die Studie untersucht erstmals systematisch Erich Kästners bislang nur marginal erforschte Rolle als Intellektueller nach dem Zweiten Weltkrieg. Ausgehend von der Annahme der Intellektuellensoziologie, dass Reichweite und Wirkungschancen eines Intellektuellen maßgeblich von dem Prestige abhängen, das er in seinem eigentlichen Tätigkeitsbereich gewonnen hat, beleuchtet die Verfasserin zunächst die Nachkriegskarriere Kästners und seine unterschiedlichen Positionen im kulturellen Feld. Daran anknüpfend zeigt sie auf, wie Kästner den Einfluss und die Bekanntheit, die er als Schriftsteller, Journalist und PEN-Präsident erlangen konnte, nutzte, um sich innerhalb (kultur-)politischer Diskurse öffentlich zu positionieren. Im Fokus steht dabei seine Auseinandersetzung mit der deutschen Schuldfrage, seine Kritik an personellen und mentalen Kontinuitäten des NS-Regimes und sein Einsatz für den Frieden. Durch die konsequente Berücksichtigung der historischen und diskursiven Kontexte seiner Stellungnahmen offeriert die Studie nicht nur neue Erkenntnisse für die Kästner-Forschung, sondern erweitert zugleich auch die literatur-, zeit- und intellektuellengeschichtliche Perspektive auf die unmittelbaren Nachkriegsjahre und die junge Bundesrepublik.

### Erich Kästner und die Moderne

The Russian Great Reforms of the 1860s were the last major modernizing effort by the Romanov dynasty. From 1855 to 1861, Grand Duchess Elena, born Princess Charlotte of Württemberg (1807-1873), acted as the spokeswoman for the reform-minded circles of Russian society, bringing before her nephew Emperor Alexander II a group of civic-minded experts who formed the core of the committee that prepared the greatest and most complex of the reforms, the abolition of serfdom in Russia. Becoming a Romanov. Grand Duchess Elena of Russia and her World (1807–1873)

Some countries (Sweden) adopted British organisational principles but not the reliance on coal; others (Russia) maintained different iron making sectors - one coal-based, the other loyal to charcoal - in parallel.

Drawing on her personal interviews with Asian-American writers, Kim also conveys their attitudes towards their own group, other Asian-Americans, other racial minorities, and white Americans—a complex mix of bitterness, acceptance, and militance. #### The Big Aiiieeeee!

Drawing on a wide array of literary, historical, and theoretical sources, Rachel Lee addresses current debates on the relationship among Asian American ethnic identity, national belonging, globalization, and gender. Lee argues that scholars have traditionally placed undue emphasis on ethnic-based political commitments--whether these are construed as national or global--in their readings of Asian American texts. This has constrained the intelligibility of stories that are focused less on ethnicity than on kinship, family dynamics, eroticism, and gender roles. In response, Lee makes a case for a reconceptualized Asian American criticism that centrally features gender and sexuality. Through a critical analysis of select literary texts--novels by Carlos Bulosan, Gish Jen, Jessica Hagedorn, and Karen Yamashita--Lee probes the specific ways in which some Asian American authors have steered around ethnic themes with alternative tales circulating around gender and sexual identity. Lee makes it clear that what has been missing from current debates has been an analysis of the complex ways in which gender mediates questions of both national belonging and international migration. From anti-miscegenation legislation in the early twentieth century to poststructuralist theories of language to Third World feminist theory to critical studies of global cultural and economic flows, *The Americas of Asian American Literature* takes up pressing cultural and literary questions and points to a new direction in literary criticism.

The derivation of Lady Macbeth's dashing image cannot be in doubt.

## Rapt in Secret Studies

"Rapt in Secret Studies": *Emerging Shakespeares* is a collection of new essays in Shakespeare Studies from a generation of scholars presently emerging out of Australia and New Zealand. These 18 essays respond in a myriad of ways to the challenge of Prospero's phrase from *The Tempest*, in which he tells his daughter Miranda that in his life before the island he had been "rapt in secret studies"-to an early modern audience, these words were likely to mean much more than a predilection for the black arts, as modern audiences tend to hear in them. Each of the key words used by Prospero evoked a range of meanings in early modern times, to which the emerging scholars represented in this collection responded by imagining new pathways in Shakespeare Studies, a field of study that has in recent times risked being marginalised even within the traditional liberal arts. The "secret studies" of which Prospero speaks are, in fact, more liberal than dark, and so the response by new scholars to a challenge issued by one of Shakespeare's characters more than four centuries ago has a renewed sense of relevance in the academy today. The essays are divided into three sections, each of which is oriented toward meanings that are specifically associated with one of the key terms in Prospero's phrase. The "rapt" section has essays concerned with excess in its various forms-jealousy, obsession, sex, violence, and even death-as well as with travel and its impact on ways of knowing about the world. In the "secret" section, the nature of things about which the early modern could scarcely speak are taken into consideration, with essays on prevailing early modern myths, infidelities, stillborn children, contagion, and the instruments of secrecy such as gossip and spies. Finally, in the "study" section, essays cover issues related both to early modern textual practice-the use of historical source materials in Shakespeare's writing, questions of multiple authorship, and the issue of early modern style and kinds of drama-and to more modern scholarly practice, such as the role of Shakespeare in the New Bibliography and the New Historicism.

She documents a sharp, upward learning curve, with the initial penning of works she examines in the following chronological order: *Caesar’s Revenge*, *II Henry VI*, *The Taming of a Shrew*, *III Henry VI*, *Edward III*, *Titus Andronicus*, *Thomas of Woodstock*, *Romeo and Juliet*, and *I Henry IV*, and separates certain plays into Marlowe and Nashe components. Those who read Murphy’s book with an open mind are likely to find her work surprisingly convincing.

#### Heinz-Uwe Haus and Theatre Making in Cyprus and Greece

### Shakespeare As a Dramatic Artist

As a creative medium, ancient Greek tragedy has had an extraordinarily wide influence: many of the surviving plays are still part of the theatrical repertoire, and texts like *Agamemnon*, *Antigone*, and *Medea* have had a profound effect on Western culture. ### The Hidden Lives of Shakespeare and Bacon and Their Business Connection

Shifts in how pardoning was represented on the stage and discussed in political tracts and in Parliament reflected the transition from a more monarchical and judgment-focused form of the concept to an increasingly parliamentary and legislative vision of sovereignty. Meyler shows that on the English stage, individual pardons of revenge subtly transformed into more sweeping pardons of revolution, from Shakespeare's *Measure for Measure*, where a series of final pardons interrupts what might otherwise have been a cycle of revenge, to later works like John Ford's *The Laws of Candy* and Philip Massinger's *The Bondman*, in which the exercise of mercy prevents the overturn of the state itself. In the political arena, the pardon as a right of kingship evolved into a legal concept, culminating in the idea of a general amnesty, the "Act of Oblivion," for actions taken during the English Civil War. Reconceiving pardoning as law-giving effectively displaced sovereignty from king to legislature, a shift that continues to attract suspicion about the exercise of pardoning. Only by breaking the connection between pardoning and sovereignty that was cemented in seventeenth-century England, Meyler concludes, can we reinvigorate the pardon as a democratic practice.

John Dover Wilson's New Shakespeare, published between 1921 and 1966, became the classic Cambridge edition of Shakespeare's plays and poems until the 1980s. The series, long since out-of-print, is now reissued. Each work is available both individually and as a set, and each contains a lengthy and lively introduction, main text, and substantial notes and glossary printed at the back. The edition, which began with *The Tempest* and ended with *The Sonnets*, put into practice the techniques and theories that had evolved under the 'New Bibliography'. Remarkably by today's standards, although it took the best part of half a century to produce, the New Shakespeare involved only a small band of editors besides Dover Wilson himself. As the volumes took shape, many of Dover Wilson's textual methods acquired general acceptance and became an established part of later editorial practice, for example in the Arden and New Cambridge Shakespeares.
