The distinctive features of this book are its sweep and that it does not shy away from controversial issues. For example, there is no question that aspects of Maoism were disastrous but Bramall argues that there was another side to the whole programme. Bramall makes it clear that unless radical change takes place, Chinese growth will not be sustainable. In the quarter century after the founding of the People's Republic of China in 1949, Beijing assisted Vietnam in its struggle against two formidable foes, France and the United States. Indeed, the rise and fall of this alliance is one of the most crucial developments in the history of the Cold War in Asia. Drawing on newly released Chinese archival sources, memoirs and diaries, and documentary collections, Qiang Zhai offers the first comprehensive exploration of Beijing's Indochina policy and the historical, domestic, and international contexts within which it developed. In examining China's conduct toward Vietnam, Zhai provides important insights into Mao Zedong's foreign policy and the ideological and geopolitical motives behind it. Throughout the 1950s and 1960s, he shows, Mao considered the United States the primary threat to the security of the recent Communist victory in China and therefore saw support for Ho Chi Minh as a good way to weaken American influence in Southeast Asia. In the late 1960s and 1970s, however, when Mao perceived a greater threat from the Soviet Union, he began to adjust his policies and encourage the North Vietnamese to accept a peace agreement with the United States.

China and the Vietnam Wars, 1950-1975

Drawing on a wealth of new sources, this work documents the evolving relationship between Moscow and Peking in the twentieth century. Using newly available Russian and Chinese archival documents, memoirs written in the 1980s and 1990s, and interviews with high-ranking Soviet and Chinese eyewitnesses, the book provides the basis for a new interpretation of this relationship and a glimpse of previously unknown events that shaped the Sino-Soviet alliance. An appendix contains translated Chinese and Soviet documents - many of which are being published for the first time. The book focuses mainly on Communist China's relationship with Moscow after the conclusion of the treaty between the Soviet Union and Kuomintang China in 1945, up until the signing of the treaty between Moscow and the Chinese Communist Party in 1950. It also looks at China's relationship with Moscow from 1920 to 1945, as well as developments from 1950 to the present. The author reevaluates existing sources and literature on the topic, and demonstrates that the alliance was reached despite disagreements and distrust on both sides and was not an inevitable conclusion. He also shows that the relationship between the two Communist parties was based on national interest politics, and not on similar ideological convictions.

American Sociological Review

He foregrounds the historical links between Malaysia and other Chinese-speaking regions, tracing how Mahua writers engage in the “worlding” of modern Chinese literature by navigating interconnected literary spaces. Focusing on writers including Lin Cantian, Han Suyin, Wang Anyi, and Li Yongping, whose works craft signature literary languages, Chan examines narrative representations of multilingual social realities and authorial reflections on colonial Malaya or independent Malaysia as valid literary terrain. Delineating the inter-Asian “crossings” of Mahua literary production—physical journeys, interactions among social groups, and mindset shifts—from the 1930s to the 2000s, he contends that new perspectives from the periphery are essential to understanding the globalization of modern Chinese literature. By emphasizing the inner diversities and connected histories in the margins, *Malaysian Crossings* offers a powerful argument for remapping global Chinese literature and world literature.

The Soviet Union and Communist China 1945-1950: The Arduous Road to the Alliance

Language matters in China. It is about power, identity, opportunities, and, above all, passion and nationalism. Fifty Years of Regional Inequality in China

The first revolution in the Chinese countryside was the land reform implemented in the 'liberated areas' and extended throughout China after the proclamation of the People's Republic of China in 1949. This was important in the consolidation of the Communist Party's political power. The second revolution was the decollectivization of agriculture and the shift to the household responsibility system as a basis for agricultural production. The phenomenal increase in Chinese agricultural output from 1978 to 1984 resulted partly from the new system of production and with a resulting explosion of farm incomes. The second revolution in the Chinese countryside from the late 1970s set the scene for the third revolution: the freeing of markets for farm products and the linking of domestic markets and international markets. The third revolution is still in progress and this book explores its beginnings. Initially, the book covers the issues of poverty in China and feeding the population. The second section describes the agricultural markets in China and the price reform of agricultural products. The next two parts discuss international and regional issues of China's agricultural economy. Finally there are contributions on what institutional changes have been associated with the third agricultural revolution. The contributions are from a team of experts on the Chinese economy from inside and outside China led by Professor Garnaut.

Agricultural Development in Qing China

"Sainthood" has been, and remains, a contested category in China, given the commitment of China's modern leadership to secularization, modernization, and revolution, and the discomfort of China's elite with matters concerning religion. However, sainted religious leaders have succeeded in rebuilding old institutions and creating new ones despite the Chinese government's censure. This book offers a new perspective on the history of religion in modern and contemporary China by focusing on the profiles of these religious leaders from the early 20th century through the present. Edited by noted authorities in the field of Chinese religion, *Making Saints in Modern China* offers biographies of prominent Daoists and Buddhists, as well as of the charismatic leaders of redemptive societies and state managers of religious associations in the People's Republic. The biographies illustrate how these leaders deployed and sometimes retooled traditional themes in hagiography and charismatic communication to attract

followers and compete in the religious marketplace. Negotiation with often hostile authorities was also an important aspect of religious leadership, and many of the saints' stories reveal unexpected reserves of creativity and determination. The volume's contributors, from the United States, Canada, France, Italy, China, and Taiwan, provide cutting-edge scholarship. Taken together, these essays make the case that vital religious leadership and practice has existed and continues to exist in China despite the state's commitment to wholesale secularization.

The Chinese Economy

The first book to document the peasant rebellion against Soviet collectivization, *Peasant Rebels Under Stalin* retrieves a crucial lost chapter from the history of Stalinist Russia. The peasant revolt against collectivization, as reconstructed by author Lynne Viola, was the most violent and sustained resistance to the Soviet state after the Russian Civil War. Conservative estimates suggest that over the course of the 1920s and early 1930s, more than 1,100 people were assassinated, more than 13,000 villages rioted, and over 2.5 million people participated in this active struggle of resistance. This book is about the men and women who tried to preserve their families, communities, and beliefs from the depredations of Stalinism. Their acts were often heroic, but these heroes were homespun,

ordinary people who were driven to acts of desperation by cruel and brutal state policies. This is a study of peasant community, culture, and politics through the prism of resistance. Based on newly declassified Soviet archives, including previously inaccessible OGPU (secret police) reports, Viola's work documents the manifestation in Stalin's Russia of universal strategies of peasant resistance in what amounted to a virtual civil war between state and peasantry. This book is must reading for scholars of Soviet history, Stalinism, popular resistance, and Russian peasant culture.

American National Security

The Project on National Security Reform submitted its 2-year study of the national security system, *Forging a New Shield*, to the President, President-elect, and Congress on November 26, 2008. Before the Project finalized the report's recommendations, its Vision Working Group tested the findings against a diverse set of scenarios to determine if the recommendations were robust and effective. This volume documents the scenario-testing process used by the Vision Working Group and includes the actual pre-reform and post-reform scenarios and details many other scenario techniques used in the overall study. Results revealed that each of the five major findings improved the performance of the current national security system, but, on the whole, the findings concluded that the national security system was at risk of failure and needed serious reform. The contributors explore how assertions of secrecy and national security in each of these areas affect the functioning of the legal system and the application of procedural justice and fairness. Students, professors and researchers interested in constitutional law, international law, comparative law and issues of terrorism and security will find this an invaluable addition to the literature. Security policy is a key factor not only of domestic politics in the U.S., but also of foreign relations and global security. By combining both the theory and process, this textbook reveals all aspects of the making of national security policy in United States from agenda setting to the successes and failures of implementation.
