For Marco D'Eramo, tourism is not just the most important industry of the century, generating huge waves of people and capital, calling forth a dedicated infrastructure, and upsetting and repurposing the architecture and topography of our cities. It also encapsulates the problem of modernity: the search for authenticity in a world of ersatz pleasures. D'Eramo retraces the grand tours of the first globetrotters - from Francis Bacon and Samuel Johnson to Arthur de Gobineau and Mark Twain - before assessing the cultural meaning of the beach holiday and the 'UNESCO-cide' of major heritage sites. The tourist selfie will never look the same again.

# Marginal Voices, Marginal Forms

Diaristic writing has often been relegated to the fringes of literary studies as a marginal cultural activity. This volume seeks to challenge that marginality by exploring some of the wide-ranging forms of literary practice encompassed by diaristic writing in Europe from the Renaissance to the present day. The volume deals with questions of the value and status of the diary, of the functioning of the diary in society and history, and of the reception and interpretation of the multifarious forms of first-person daily writing. The volume investigates diaries across national borders and linguistic boundaries, so as to make the hitherto marginal place of the private journal a site of fruitful interdisciplinary encounters. Australian, British, Catalonian, French, German and Italian critics examine diaries dating from the sixteenth to the twentieth century, within the context of the literature, history and literary history of Catalonia, England, France, Germany and Italy. A prime concern of the essays in this collection is to highlight the cultural, generic and historical diversity of the diary, while emphasising the points of convergence between different texts and differing critical approaches to the texts. The volume will be of interest to students and teachers of European and comparative literature.

# Color Symbolism in the Works of Stendhal

This study shows an apparent distinctive pattern of color symbolism in Stendhal's works, while serving to unify the characters and events in Stendahal's fiction. The analysis of his non-fiction writings reveals his sensitivity to colors; notably, his autobiography serves as a touchstone to the elaboration of his color symbolism. An examination of his fiction works that include Armance, Le Rouge et le Noir, Lucien Leuwen, La Chartreuse de Parme, and Lamiel, all show various representations of Stendhal's distinctive color palette.

### La Perte

Cet ouvrage entend analyser et repérer le sentiment de la perte exprimé par le sujet-écrivain, tout en le définissant comme constitutif de l'acte littéraire et consubstantiel à son existence. À travers l'analyse des oeuvres de Stendhal (Vie de Henry Brulard) de Proust et de Céline (Mort à crédit), ce sentiment est étudié du point de vue littéraire et psychanalytique, tout en accordant à l'analyse textuelle une primauté indispensable, révélant les hésitations, les non-dits et les silences paradoxaux de l'écriture. Chacun à leur manière, Stendhal, Proust et Céline expriment ce sentiment, notamment en ce qui concerne la perte de la relation maternelle, perte réelle, redoutée ou mème, chez Céline, singulièrement exposée dans un refus du fonctionnement oedipien classique. La lecture de ces trois oeuvres souligne ainsi un fondement du sujet psychique sublimé dans l'acte littéraire.

# La Légende de Venise

C'est à Venise que j'ai décidé toute ma vie" écrit Barrés en préfaçant sa trilogie du Culte du Moi, en 1892. Et Venise représente en effet le lieu fondateur de son expérience d'écrivain. D'abord ville de l'individualisme triomphant, de la réclusion orgueilleuse et de l'édification de soi, Venise devient progressivement la ville des miasmes, du pourrissement et de la volupté morbide. Cette métamorphose de la figure de la ville, corollaire de l'enracinement lorrain de Barrès, permet de rendre compte de l'évolution profonde de l'œuvre mais en même temps de sa cohérence. Mélange de fascination et de répulsion, de désir et de rejet, le rapport de Barrès à Venise révèle celui qu'il entretient avec l'écriture. Le livre étudie les diverses figurations de Venise dans l'œuvre de Barrès - Venise égotiste d'Un Homme libre (1889), Venise utopique de L'Ennemi des lois (1892) et romanesque de L'Appel au soldat (1900), Venise poétique d'Amori et Dolori sacrum (1903) - et montre comment chacune engage une réflexion sur l'acte même d'écrire. À celui qui vit dans le désir et le souci d'être soi, Venise fait entendre le chant mêlé de la liberté, de la puissance et de la vanité. C'est pourquoi la légende de Venise composée par

Barrès parle de la solitude, de la communauté idéale et peut-être introuvable, du triomphe et de la mort. Elle parle d'enchantement et de peur, d'enthousiasme et de doute de l'écriture comme tentation et de la tentation comme accomplissement.

### Le Génie de l'Italie

Depuis la Renaissance et l'avènement du « Voyage d'Italie », il est peu de pays qui aient fait écrire comme l'Italie, devenue au fil des siècles une bibliothèque tout autant qu'un vaste musée, un pays-livre avant d'être un pays libre. La rencontre des Européens avec la péninsule a généré toute une série d'images culturelles, associées aux quatre cités du « Grand Tour », Venise, Florence, Rome et Naples, mais aussi aux marges et frontières d'un pays étiré entre les Alpes et les îles du "Mezzogiorno". # Flüchtigkeit

Old Europe's new crisis. Europe, the charming continent of windmills and gondolas. # Die Erfindung einer Epoche

L'opéra, fait de civilisation majeur dans nos sociétés, est étudié à travers le prisme de ce que Walter Benjamin a appelé l'« un des grands romans sur le xixe siècle » : Le Fantôme de l'Opéra de Gaston Leroux. De multiples adaptations cinématographiques mêlent grandioses réalisations de studios (Universal, Hammer) et films d'auteur cultes (Brian de Palma, Dario Argento), au risque du kitsch. La comédie musicale d'Andrew Lloyd Webber pulvérise tous les records d'audience et de longévité, parachevant un mythe. Quelles conceptions de l'opéra se fait-on et quelles représentations en donne-t-on quand on passe du roman à son illustration, du cinéma à la comédie musicale et du ballet à la fan fiction? Mais aussi du grand répertoire lyrique au rock ou au heavy metal, de la féerie à l'horreur, des adultes aux adolescents, des hommes aux femmes, d'un siècle à l'autre ? Ou encore de la France aux États-Unis et à la Chine, et de la Grande-Bretagne à l'Italie et à l'Amérique du Sud ? Cet essai interroge le devenir du divertissement en Occident, de l'essor du spectaculaire romantique au triomphe de l'industrie culturelle mondialisée. Il montre que si l'opéra comme genre et pratique semble s'effacer peu à peu, son esprit perdure sous d'autres formes et par d'autres moyens : l'opéra et ses succédanés prennent en charge des aspirations dont l'homme ne peut se passer et dont eux seuls ont la clef. Plus largement, cet ouvrage s'attache à ce que Nietzsche a nommé la « civilisation de l'opéra » et dont le Palais Garnier, quintessence de « Paris, capitale du xixe siècle » et de la culture bourgeoise à son âge d'or, apparaît comme la figure de proue. S'appuyant sur les sources les plus diverses, il parcourt tout l'édifice de son imaginaire pour identifier dans le couple formé par l'Opéra fabuleux et

son Fantôme monstrueux l'allégorie d'une modernité équivoque. Il traite enfin de notre rapport à cette civilisation, fantôme étonnamment vivace des cultures et sociétés contemporaines. Timothée Picard est professeur de littérature générale et comparée à l'Université de Rennes et membre de l'Institut universitaire de France. Il est spécialiste des conceptions et représentations de la musique à travers la littérature, les arts et l'histoire des idées – domaine auquel il a consacré de nombreux ouvrages souvent récompensés.

#### Vieille Rome

Est-il aussi aisé de définir les propriétés du registre sapiential que celles des registres tragique, épique ou comique ? Le contenu de ce livre répond à la question par le caractère pluriel des contributions qui y sont réunies. En effet, afin de confronter leurs analyses, des chercheurs issus de la communauté scientifique française et internationale (Afrique, Europe, Océan Indien, États-Unis) ont rallié Metz, en septembre 2005, pour le premier volet du colloque consacré au livre de sagesse, sous l'égide du Centre de recherche « Écritures » de l'Université Paul Verlaine. # La Civilisation de l'opéra

Et comment ce théâtre des traditions ne parle en fin de compte que d'aujourd'hui.

This book focuses on the complex ways in which architectural practice, theory, patronage, and experience became modern with the rise of a mass public and a reconfigured public sphere between the end of the seventeenth century and the French Revolution. Presenting a fresh theoretical orientation and a large body of new primary research, this book offers a new cultural history of virtually all the major monuments of eighteenth-century Parisian architecture, with detailed analyses of the public debates that erupted around such Parisian monuments as the east facade of the Louvre, the Place Louis XV [the Place de la Concorde], and the church of Sainte-Genevieve [the Pantheon]. ### Architecture, Print Culture and the Public Sphere in Eighteenth-Century France

La conception des formes et le choix des matériaux relèvent non seulement du goût de l'architecte, de l'ingénieur ou du sculpteur qui en donne les plans, mais aussi de nombreux impératifs techniques, dictés par la présence de l'eau et les activités qui en découlent. Commanditaires, concepteurs, maîtres d'oeuvre et usagers représentent ensemble toute la population citadine. C'est pourquoi le récit de la construction des aqueducs, des châteaux d'eau et des fontaines, et celui de leur entretien, met en scène la ville entière, révèle ses besoins, ses activités, ses aspirations et ses ambitions. Le monument hydraulique, objet d'utilité et objet de mémoire, est susceptible d'en rendre compte. Équipement ou véritable monument commémoratif, sa structure et son décor racontent l'histoire de la vie quotidienne, de l'exercice du pouvoir, des arts de la construction, des techniques, l'histoire de la sculpture, de l'architecture et des embellissements, et, à travers ces différentes disciplines, l'histoire des idées.

#### Les monuments de l'eau

# Archaeology in South Carolina

The rich human history of South Carolina from its earliest days to the present Adam King's Archaeology in South Carolina contains an overview of the fascinating archaeological research currently ongoing in the Palmetto state featuring essays by twenty scholars studying South Carolina's past through archaeological research. The scholarly contributions are enhanced by more than one hundred black and white and thirty-eight color images of some of the most important and interesting sites and artifacts found in the state. South Carolina has an extraordinarily rich history encompassing the first human habitation of North America to the lives of people at the dawn of the modern era. King begins the anthology with the basic hows and whys of archeology and introduces readers to the current issues influencing the field of research. The contributors are all recognized experts from universities, state agencies, and private consulting firms, reflecting the diversity of people and institutions that engage in archaeology. The volume begins with investigations of some of the earliest Paleo-Indian and Native American cultures that thrived in South Carolina, including work at the Topper Site along the Savannah River. Other essays explore the creation of early communities at the Stallings Island site, the emergence of large and complex Native American polities before the coming of Europeans, the impact of the coming of European settlers on Native American groups along the Savannah River, and the archaeology of the Yamassee, apeople whose history is tightly bound to the emerging European society. The focus then shifts to Euro-Americans with an examination of a long-term project seeking to understand George Galphin's trading post established on the Savannah River in the eighteenth century. A discussion of Middleburg Plantation, one of the oldest plantation houses in the South Carolina lowcountry, is followed by a fascinating glimpse into how the city of Charleston and the lives of its inhabitants changed during the seventeenth and eighteenth centuries. Essays on underwater archaeological research cover several Civil War-era vessels located in Winyah Bay near Georgetown and Station Creek near Beaufort, as well as one of the most famous Civil War naval vessels—the H.L. Hunley. The volume concludes with the recollections of a life spent in the field by South Carolina's preeminent historical archaeologist Stanley South, now retired from the South Carolina Institute of Archaeology and Anthropology at the University of South Carolina.

### Museums, Narratives, and Critical Histories

In response to systemic racism and institutions' implications in histories of colonialism, nationalism, and exclusion, museum curators have embraced new ways of storytelling to face entangled memories and histories. Critical museum practices have consciously sought to unsettle established forms of representation, break with linear narratives of progress, and experiment with new modes of multivocal, multimedia, and subjective storytelling. The volume features analyses of narratives and narration in museums and heritage institutions today, as well as visions for future museum practices on a local, regional, national, transnational, and global scale. It is divided into three sections: Narrative Theory and Temporality, Ruptures and Repair, and Difficult Memories and Histories. Essays from a variety of disciplines in the humanities and social sciences examine museum practices in history, memorial, anthropological, and art museums across six continents. They develop narratological categories, reflect on immersive and virtual narratives, challenge colonial violence and hegemonic forms of representation, query the performance of heritage, parse exhibition design, and unearth techniques to express narratives of social justice.

# Memory, Heritage, and Preservation in 20th-Century England

This book explores commemoration practices and preservation efforts in modern Britain, focusing on the years from the end of the First World War until the mid-1960s. The changes wrought by war led Britain to reconsider major historical episodes that made up its national narrative. Part of this process was a reassessment of heritage sites, because such places carry socio-political meaning as do the memorials that mark them. This book engages the four-way intersection of commemoration, preservation, tourism, and urban planning at some of the most notable historic locations in England. The various actors in this process—from the national government and regional councils to private organizations and interested individuals—did nothing less than engineer British national memory. The author presents case studies of six famous British places, namely battlefields (Hastings and Bosworth), political sites (Runnymede and Peterloo), and world's fairgrounds (the Crystal Palace and Great White City). In all three genres of heritage sites, one location developed through commemorations and

tourism, while the other 'anti-sites' simultaneously faltered as they were neither memorialized nor visited by the masses. Ultimately, the book concludes that the modern social and political environment resulted in the revival, creation, or erasure of heritage sites in the service of promoting British national identity. A valuable read for British historians as well as scholars of memory, public history, and cultural studies, the book argues that heritage emerged as a discursive arena in which British identity was renegotiated through times of transitions, both into a democratic age and an era of geopolitical decline.

Using ranchers' personal papers, publications, and cattle growers association records, the book provides an inside view of how range cattle ranchers in Arizona, New Mexico, Colorado, Wyoming, and Montana created a culture and a shared identity that would frame and inform their relationship with their environment and with society at large in an increasingly challenging, modernizing world. A multifaceted analysis of postwar ranch life, labor, and culture, this innovative work offers unprecedented insight into the cohesive political and cultural power of western ranchers in our day.

With remarkable depth and breadth, this book unravels both a bygone and a continuing human pursuit of artefacts—shared, spiritual, modern, and above all beautiful that have linked so many lives, Chinese and foreign.

### 20th Century Russia

1917 saw one of the most dramatic revolutions in world history when the workers of Russia united to throw out their tsar and aristocracy, and formed the first communist state. A century later, this book reflects on the reasons for this revolution, key people, events and its legacy. Illustrated with archive photography, posters and artefacts, and supported by eyewitness accounts, this book explores Russia's century of upheaval. It considers how change affected not only people such as Lenin, Stalin and Tsar

Nicholas II, but also the ordinary Russians. It explores the roles of the Bolsheviks, the Mensheviks and the secret police, and it also looks at the arts, education, family life, sport, and the revolution's impact on global politics and cultural attitudes. The twentieth century was also dramatic in terms of world politics and this book examines all of this change within the context of the First World War, the Second Word War, the Civil War between the Reds and the Whites and the Cold War. It explores Perestroika and Glasnost and how 21st-century Russia emerged from the collapse of the Soviet Union. For children aged 12+, this book is especially aimed at history students who are studying the Russian Revolution and Russian history. The author, Heather Maisner, studied Comparative Studies, English and Russian at university and has translated books from the Russian. The highly respected Russian historian, academic and author of many books on the subject, Geoffrey Hosking, has acted as consultant. He is the Emeritus Professor of Russian History at UCL, and has published a number of best-selling books on Russia.

#### Between Art and Artifact

Oaxaca is internationally renowned for its marketplaces and archaeological sites where tourists can buy inexpensive folk art, including replicas of archaeological treasures. Archaeologists, art historians, and museum professionals sometimes discredit this trade in "fakes" that occasionally make their way to the auction block as antiquities. Others argue that these souvenirs represent a long cultural tradition of woodcarving or clay sculpting and are "genuine" artifacts of artisanal practices that have been passed from generation to generation, allowing community members to preserve their cultural practices and make a living. Exploring the intriguing question of authenticity and its relationship to cultural forms in Oaxaca and throughout southern Mexico, Between Art and Artifact confronts an important issue that has implications well beyond the commercial realm. Demonstrating that identity politics lies at the heart of the controversy. Ronda Brulotte provides a nuanced inquiry into what it means to present "authentic" cultural production in a state where indigenous ethnicity is part of an awkward social and racial classification system. Emphasizing the world-famous woodcarvers of Arrazola and the replica purveyors who come from the same community, Brulotte presents the ironies of an ideology that extols regional identity but shuns its artifacts as "forgeries." Her work makes us question the authority of archaeological discourse in the face of local communities who may often see things differently. A departure from the dialogue that seeks to prove or disprove "authenticity," Between Art and Artifact reveals itself as a commentary on the arguments themselves, and what the controversy can teach us about our shifting definitions of authority and authorship.

# **Traveling Auteurs**

What tensions characterized the relationships between cinema, European Leftists, and emerging post-colonial ideologies after World War II? In Traveling Auteurs, author Luca Caminati analyzes the work of influential Italian filmmakers Roberto Rossellini, Pier Paolo Pasolini, and Michelangelo Antonioni as they engaged politically and aesthetically with the global landscapes and politics of the Cold War period. As documentaries, the films considered in this book record specific manifestations of political sensibilities of the twentieth century. As bodies of work, they reveal that the traveling auteurs who made them were symptomatic actors in complex geopolitical networks. As cultural objects reflecting and shaping contemporaneous debates, they provoke a complex afterlife at home and abroad. In the three chapters dedicated to Rossellini in India, Pasolini in Africa and the Middle East, and Antonioni in China, Caminati pays particular attention both to the reception that these films had in the countries where they were shot and to their legacies in Italian film history. As it follows the entanglements of filmmakers, artists, and activists involved as allies or direct witnesses to momentous political change, this book sheds new light on anticolonial struggles, the reaffirmation of the Non-Aligned Movement, and the consolidation of the Chinese Communist Party.

The power of example,

To have soft power, you need to be connected, and the interaction, management and dissemination of assets can be seen as exercises in soft power action. This book seeks to detail in examples how the concept of "soft power" encompasses and problematizes the multiplicity of themes on the contemporary international agenda, focusing on one of its least discussed elements: the universe of international cultural heritage and the relationship between actors and society, preservationist actions in the globalized world. In addition, by centering an area of collection rather than an institution, he opens new areas of investigation that include non-professional ethnographic collectors and a sustained rather than superficial consideration of Indigenous peoples as producers behind the material culture. Hoarding New Guinea answers the call for a more significant historical focus on colonial ethnographic collections in European museums.

The history of printing, books, and libraries, is confined only to a limited extent within the boundaries of individual countries. There are, indeed, few historical developments which have played a more universal role, in reaction against all kinds of particularism, than type design, printing, book production, publishing, illustration, binding, librarianship, journal ism, and related subjects. Their history should be assessed and studied primarily in an international, not in a local, context.
